• Presentation by 2017 Arts Grant Recipient: Lauren Chambers, The Urbana Free Library

Ms. Sammann introduced Lauren Chambers, Adult & Youth Services Librarian at The Urbana Free Library. Ms. Chambers gave a slideshow presentation on her event which featured New York Times best-selling young adult author, Maggie Stiefvater. The event took place on November 15th at the Urbana Free Library. Maggie Stiefvater spoke about her latest book, *All the Crooked Saints*, and answered audience questions about her books and the novel writing process. She followed the talk with a book signing. There were 175 people in attendance. Ms. Chambers thanked the Commission for the grant received. At the conclusion of the report, questions and comments from the Commission were heard.

Presentation by 2017 Arts Grant Recipient: Jancie Philippus, University of Illinois School of Music

Ms. Sammann introduced Jancie Philippus, Public Engagement Coordinator at the University of Illinois School of Music. Ms. Philippus gave a slideshow presentation on her project titled, *ISYM Hip-Hop* which took place from July 15-22, 2017. She stated that the Illinois Summer Youth Music Program is always looking to expand the diversity of their curriculum. Adding this hip-hop addition to the program was a great success. 9 students participated in the project, and they all wrote, recorded, and performed original music in one week's time! The final performance took place at the Canopy Club, and gave them a real-life Hip-Hop musician experience. Following the camp, a few of the students have actually been booked to perform shows in the community. Ms. Philippus thanked the Commission for the grant received. At the conclusion of the report, questions and comments from the Commission were heard.
