D. PRESENTATIONS AND PUBLIC INPUT

1. Economic Development Quarterly Report

Community Development Economic Coordinator Stepheny McMahon presented the quarterly report, highlighting the following:

- Covid-19 Resources for Business payroll protection program (PPP), curbside, online, and sidewalk sales.
- City Events

- → Market at the Square with a 90% compliance for wearing masks and following traffic signage, attendance has reached over 3,000 attendees.
- → Urbana Arts & Culture Program has hosted a variety of online and virtual activities for the public. Poets on a Park Bench, new Mural on Glass was installed, and local artists were awarded stipends to create outdoor installation in several Champaign Urbana parks and community gardens.
- New Business, Expansion, and changes
 - → Work in progress at the Gather mixed use project at University and Lincoln Ave., 200 Vine St., 1007 University Ave., all on target for completion.
 - → New businesses opening Ceptier, a technology consulting company; Restyle at Bella, women's boutique and consignment shop; Kutz barbershop. Ribbon cuttings will be held virtually.
- Think Urbana
 - → The program continues to be of interest as people take advantage of low mortgage interest rates.

2. COVID-19 Modeling: Implications for UIUC re-opening and City of Urbana Policy

Eric Jakobsson and Santiago Nuñez Corrales from University of Illinois gave a brief summary about their Epidemiology Workbench model, which is a tool for communities to strategize in response to COVID-19 and other infectious diseases. Mr. Jakobsson said the research showed testing is more important than social distancing. In addition, Mayor Marlin said that City of Champaign, University of Illinois, and City of Urbana are working collaboratively by implementing emergency orders prior to students' arrival. Some of the emergency orders will address face covering enforcement, indoor/outdoor dining restrictions, and private gatherings. Discussion ensued.

3. Clarification of Juvenile Arrest and Detention Data

Mayor Marlin said that this presentation was going to be brief, to merely address some of the data presented during public input last week. Regarding the disproportionate number of juvenile arrest and detention among the African American youth in Urbana.

Police Chief Bryant Seraphin provided clarification of juvenile arrest and detention data for 2019. The previous information presented said that there were 252 arrests, but it was 205 showing 84% of those being African American youth. In addition, showing disposition for all youth as follows:

- → Juvenile Detention Center (JDC)
- → Youth Assessment Center (YAC)
- → Warned and Released

The information shown illustrated African American Youth with the highest police contact and resulting in trips to JDC, referrals to YAC, and given a warning or released.

Chief Seraphin addressed questions from council members. Some of the comments and or questions included:

- → How many of the JDC trips resulted in felony charges?
- → How many are repeat offenders?
- → Where did the arrests originate? (SRO, field officers, schools)
- → Do officers have discretion of youth disposition?
- → Suggestion: refrain from using the word "trips" when talking about children going to jail.
- → Do not place blame on family economic status or their race.

Giovanna Dibenedetto addressed council to report improvements of violence at the Silverwood neighborhood and to invite council for a prayer walk against violence and crime. The prayer walk will be by invitation only Monday, August 17, 2020 from 5:30-6:30pm.

Dear City Council,

My name is Chelsea Birchmier, and I'm a PhD student and graduate employee at the University of Illinois, and the co-president of the Graduate Employees' Organization or GEO. Mayor Marlin indicated at the recent WILL TV panel on policing that the City of Urbana is about to renegotiate their contract with the police union, the Fraternal Order of Police. Currently, the police contract allows for the removal of disciplinary notices, seniority provisions that make it so more senior officers are not impacted by layoffs regardless of their history of misconduct, 120 hours of paid leave for police union conferences, a memorandum of understanding that renders the Civilian Police Review Board (CPRB) powerless, and other items that make it difficult to hold police accountable. What accountability measures is the city of Urbana planning to advocate for on behalf of your residents in the police union contract?

I would also like to continue to advocate that the charges against Ms. Lewis be dropped. Additionally, I support the call for an end to the intergovernmental agreement with the Urbana Police Department and the removal of SROs from Urbana's public schools as well as a significant defunding of Urbana Police to allow more funds to go toward reinvesting in Black neighborhoods.

Dear Urbana City Council -

The connection between academic underachievement and student involvement in the justice system needs to be highlighted and addressed; when students do not graduate from high school and obtain the skills to procure adequate employment, they are more likely to also be involved in the justice system at later stages in their lives. Policing was never meant to solve all problems. School Resource Officers (SROs) do not have specialized training in adolescent or childhood development. They are not mental health experts, social workers with licensed degrees, psychologists, or school counselors. They are not educators. To be clear, school resource officers are career law enforcement officers, with arresting authority, and a license to carry a weapon (paid for by the school district). Police officers patrol school hallways just like they do city streets. There are better, safer, and cheaper alternatives. We must end the Intergovernmental agreement with the Urbana Police Department and remove SROs from Urbana's public schools.

If we are to acknowledge the truth about the systemic racism in our communities, we must also acknowledge the impact that systemic racism has on youth. As a means to be actively working to be anti-racist in our educational systems, resolutions against racism are key policy doctrines that can help to govern how we think about safety, health care, the economy and certainly public schools. City Council must commit to and enact a resolution to end systemic racism and achieve racial quality. If you are looking to empower & not exploit a community, as public officials, it is your duty to use legal and moral authority to protect all members of the Urbana community, no matter their race or color, to foster a community free of fear, intimidation and violence — a community in which people are not targeted or hurt unnecessarily by law enforcement or vigilantes. It is time to take bold steps toward real action; use funds to better support the community.

Alternatives to policing are predicated on the understanding that crime often arises out of unaddressed needs. Here are some ways our community can build need-based responding: 1) Ending drug use incarceration - instead, provide services and support networks to combat drug addiction. 2) Remove SRO's - instead, train staff on restorative justice techniques, increase the number of available counselors, and grow programs (i.e. art, music, science, etc.) meant to engage students during/after school. 3) Stop policing homelessness, intoxication, domestic disputes, etc. - instead, build community intervention strategies like CAHOOTS in OR 4) End citations for things like broken tail lights (which further strain financial situations) - instead create the means to fix the issues immediately (e.g. hire city mechanics) so as not to prolong the danger posed to other drivers. 5) Addressing violence - crimes such as sexual assault are underreported.

Charges against Ms. Lewis must be dropped and the officers who brutalized her should be taken off duty pending the completion of an independent investigation of her arrest. Furthermore, there should be clear communication and transparency

between the council and the community about who is being tasked with this investigation. Regards,

To the Urbana City Council,

I am shocked and beyond dismayed that I must write again to speak out against the arrest and beating of Aleyah Lewis. I am not alone in the sentiment that my words to the City Council have not been meaningfully heard.

This young woman was in need of our community's support and not a brutal beating. Nothing about her presentation or actions was threatening. Yet, police officers chose to provoke and escalate conflict and violence rather than quell it. Their well recorded words to Aleyah were clearly not only racist but sexist and deeply disturbing. I have watched footage of the police assault on Aliyah and wondered why a male police officer would continue to physically straddle a young woman so long after she could even move at all.

Even more disturbingly, police response has been to attempt to retract and cover up evidence or present skewed and slanted information. All efforts have been invested in discrediting and blaming the victim. Investigative agencies have been hired that have clear track records of bias in favor of the police. The system has been busy stacking cards against Aleyah.

The ultimate tragedy is that the state's attorney's office sees no wrongdoing and continues to support enforcement of a possible twelve year imprisonment of this young woman. Our community pays the salaries of our police officers, attorneys, and the investigative agencies involved in these situations. We will not continue to pay for corrupt systems that victimize our fellow citizens. If police are allowed to treat Aleyah Lewis as they have then none of us are safe.

For these reasons I demand that all charges against Aleyah Lewis be dropped. I continue to stand with peaceful protesters, my professional colleagues, and the members of my faith community who demand the same. There is extensive evidence that the actions of these police officers were clearly inappropriate and we will distribute it far and wide. We will continue to relentlessly support Aleyah in every way possible and will intensify our efforts until justice is served.

To the members of the Urbana City Council,

I am writing to add my voice to the many others who have expressed concern over excessive force used by members of the Urbana Police Department in the arrest of Urbana resident Aleyah Lewis. I agree with Minnie Pearson of the NAACP in her recent commentary in the News-Gazette, in which she states that had Ms. Lewis been white, she would not have been treated in this manner by the officers. In addition, the charges against Ms. Lewis which could result in 12 years in prison are very much out of proportion to the situation in which was luckily recorded by other Urbana citizens.

I also am pretty shocked by the fact that the Urbana Police Department has not yet adopted the NAACP and IL Association of Chiefs of Police "Ten Shared Principles," common-sense principles that our Police Department should be more than willing to agree to.

I also share concerns with other Urbana residents that the Citizens Police Review Board (CPRB) has not been effective as a way to review citizen complaints against police officers, and as I've mentioned before in a previous email, I would like to see the city of Urbana re-allocate funding from policing into investments in the community.

In summary, I would like to urge the members of the City Council to:

- -contact Julia Rietz, as I have, to ask that the charges against Ms. Lewis be dropped,
- -urge the Urbana Police Dept. to sign on and adhere to the Ten Shared Principles already agreed to by the Illinois Association of Chiefs of Police: https://www.ilchiefs.org/shared-principles, and
- Re-allocate funding from policing into investments in neighborhoods, affordable food and housing, social services, education, mental health services, and public works, to more fully reflect the needs of the residents of this community, in addition to continuing to reform the CPRB to make it an effective tool of oversight.


Policing was never meant to solve all problems.

School Resource Officers (SROs) do not have specialized training in adolescent or childhood development. They are not mental health experts, social workers with licensed degrees, psychologists, or school counselors. They are not educators. To be clear, school resource officers are career law enforcement officers, with arresting authority, and a license to carry a weapon (paid for by the school district). Police officers patrol school hallways just like they do city streets. There are better, safer, and cheaper alternatives.

I have heard the mayor and police chiefs say that SROs perform good work "mentoring" students. As an educator who has mentored hundreds of students over my career thus far, I can assure **it does not require a weapon and badge to mentor students**. The massive funds that go to SROs should be reallocated to people who care for, not control, students, like nurses, counselors, career/internship and college counselors, and so on.

We must end the Intergovernmental agreement with the Urbana Police Department and remove SROs from Urbana's public schools.

Dear Urbana City Council and Urbana Police Chief Bryant Seraphin,

My name is Zach Wilken and I am an Urbana Resident. Last week at the city council meeting, the UPD police chief Seraphin justified the actions of a driver who hit a protestor with her car on June 23rd. Witnesses who saw the assault said that nothing was done to provoke this woman, no one jumped on her car (as the police chief stated) and that she was released from the scene by police, with no consequences. The police chief justified the assault by saying that the driver was upset after "visiting a loved one in the hospital."

On April 10th, Aleyah Lewis was taken into custody after a domestic dispute and discharge of a firearm.

Aleyah Lewis is on trial tomorrow for aggravated battery towards a police office. Her "crime" would have never taken place if your police officers had not failed to deescalate the situation like they did with this driver who actually committed an assault.

Aleyah Lewis was having a bad day as well. I only see two differences between Ms. Lewis's situation and that of the woman who drove through the protest.

- 1) Aleyah Lewis was not wielding the deadly weapon that could have killed a person. The driver from June was the party responsible.
- 2) While police responded to calls about both situations, they escalated the situation with Aleyah Lewis to the point where she was kicked on the ground and tasered, while the driver who actually committed an assault was allowed to go free. Similarly, after the hit and run incident in June, witnesses said that the driver was upset and yelling at police. However, police did not tackle this woman to the ground and press charges

against her, as they did with Aleyah Lewis.

For the police chief to dismiss one of these situations with empathy and not the other is unjust. I would ask the UPD and the police chief move forward to have a zero-tolerance policy on people driving through protests. This has happened multiple times now in C-U with an incident recently outside of Rogue Barber Shop. If you do not properly address these assaults, someone could be seriously injured or killed. I would also ask the police chief **AND** city council to continue to show empathy by recommending that all charges against Aleyah Lewis be dropped. If our police can deescalate one situation and empathize with the assailant, then they should have done the same with Ms. Lewis. Aleyah Lewis has already suffered enough. Please make direct statements on what you believe to be right and stay consistent with your beliefs and how you enforce them.
