Mayor Marlin administered the Oath of Office to Ms. Hursey.

Mayor Marlin thanked all involved in the search process noting that this has been the hardest decision she's had to make as mayor from an excellent pool of applicants. She thanked and recognized the applicants. She noted that she expects all to continue to be involved in Ward 3 and the city.
