- Julie Robinson Shaeffer raised questions/issues about required font size, and also making the logo smaller and the font larger.
- Peter Resnick shared the posting guidelines and shared the HRC can make font size regulations, as well as the posting location of the Rights Ordinance. Resnick also shared the word "discrimination" should be used in the poster headline.
- Julie Robinson Schaeffer added to make the email address and website lines in a different font and colors in order for them to stand out on the poster.
