#### **Old Business:**

## **New Business:**

Public Participation: None.

<u>Election of Board Officers:</u> Dave Smysor moved and Ron Eldridge seconded to nominate Jeremy Hale for Secretary.

<u>Financial Report</u>: Ron Eldridge presented the quarter report for December 2022. The amount of cash at Busey increased due to the close out of Morgan Stanley accounts and the final property tax receipt. We will be transferring an excess of approximately \$900,000 to the State Investment Fund. The Fund returned 5.9% for the quarter and -.65% since inception. No scheduled changes planned in the current quarter except for pre-approved raises.

<u>IPOPIF Report:</u> Monthly transfers of 300,000 have been scheduled for the next several months. They have to be set up one at a time. There is a wire fee.

<u>Police Pension Annual Financial Report (audit)</u> by Lauterbach and Amen: Went as expected with no unusual findings. Motion to accept by Ron Eldridge second by Dave Smysor.

Fiduciary Liability Insurance Renewal for the period 2/1/23-2/1/24 for \$4766.00. Discussion that the board should check on cyber coverage which could be very expensive and how to best protect the funds. Motion by Elizabeth Hannan second by Dave Smysor to renew the policy.

# Resignations:

Angela Vogt has received a pension analysis from Ron Eldridge and is deciding whether to remain in the fund.

Robert Ford resigned with contributions totaling \$12076.06.

Shannon Barrett transferred 6 years of service to IMRF for \$62626.17. This leaves her with 8 years of service and she would be eligible to draw a 20% pension when she turns 60.

Osric Hayes resigned 1/19/2023 and his total contributions have not been recorded yet, but he has made a refund request.

Continuing Eligibility Letters and disability physicals need to be resumed. We should also inform the pensioners of the new benefit for spouses acquired after retirement.

The next meeting is scheduled for Friday April 28, 2023 in the City Council Chambers.

There being no further items before the Board, Dave Smysor moved and Jeremy Hale seconded to adjourn the meeting.

The meeting was adjourned at 2:18 PM.
