Old Business:

Minutes (4/29/22): No corrections noted. Move to accept by E. Hannan. Second by D. Smysor

Roll call: S. Royal (yes), D. Smysor (yes), E. Hannan (yes), R. Eldridge (yes); Minutes approved.

<u>Election of Retiree Trustee:</u> Letter has been mailed out to the retirees soliciting for candidates. Steve Royal has indicated he does not wish to continue.

<u>IPOPIF</u>: Dave Smysor reported that the new transfer date is September 1. Resolutions must be on file 1 month earlier. Forms were signed based on motions at the 4/29/22 board meeting. Resolution 2202-001 for Authorized Agents. 2002-002 Account Representatives. Elizabeth Hannan emailed the completed forms. She will send out the letter of direction to our financial managers.
