The meeting was called to order by S. Royal at 1:05 PM, on July 29, 2016.

## **Old Business:**

Minutes: The minutes of April 22, 2016 were reviewed.

## **New Business:**

Public Participation: There was no public participation.

Officer Dean Hazen – Disability Hearing Status: A hearing date needs to be scheduled for D. Hazen's disability hearing. J. Dobrovolny will follow-up, schedule, and advise.

Mayoral Appointment: Mayor Prussing appointed Todd Rent to the Urbana Police Pension Board. His term is from 5/31/16 to 5/31/18. Training requirements were discussed and T. Rent will fulfill this requirement.

<u>Board Election</u>: There was interest from retired pensioners for the Board seat up for election (Steve Royal and Oscar Gamble). For the active pensioners, nobody applied; D. Pipkins will continue. Election ballots will be sent out by J. Dobrovolny's office.

Officer Preston James – Disability Application: P. James filed for a duty-related pension for an incident that occurred 12/06/14. Three independent medical evaluations will need to be done.

<u>Pensioner Duane Maxey – Retro Pay</u>: D. Maxey retired in February 2015; he was over age 55 when he retired. He is supposed to get 3% increase 12 months after he retired. He should've received a pay raise in March 2016. R. Eldridge stated he was receiving \$4,564.58, but with a 3% increase, he should've been receiving \$4,701.52 (retro pay for months March-June totaled \$547.76, plus interest of \$5.71, for a total of \$553.47). In July 2016, he will be receiving his correct amount.

Motion by S. Royal to accept the amended amounts for D. Maxey. Voice vote: D. Smysor (aye), T. Rent (aye), D. Pipkins (aye); motion carried.

<u>Springfield Update</u>: Discussion w/ Board by J. Dobrovolny, updating them on what's going on in Springfield and the Department of Insurance.

<u>Financial Report</u>: R. Eldridge distributed the Fund's quarterly report for April-June, 2016, reviewing the report w/ the Board. Motion by D. Smysor to accept the report, seconded by S. Royal, motion carried.

Investment Presentation: P. Donnelly went over the Fund's performance.

There being no further business before the Board, the meeting was adjourned at 2:17 PM.
