NOTICE OF PUBLIC HEARING OF THE CUNNINGHAM TOWNSHIP BOARD

A public hearing to approve a proposed property tax increase for the Town of Cunningham for 2021 will be held on Monday December 13th, 2021 at 6:30 PM virtually via zoom.

The corporate and special purpose property taxes extended or abated for 2020 were \$1,825,178.00. The proposed corporate property taxes to be levied for 2021 are \$2,300,000.00. This represents a 26% increase over the previous year.

The property taxes extended for debt service and public building commission leases for 2020 were \$0. The estimated property taxes to be levied for debt service and public building commission leases for 2021 are \$0. This represents a 0.00% increase over the previous year.

The total property taxes extended or abated for 2020 were \$1,825,178.00. The estimated total property taxes to be levied for 2021 are \$2,300,000.00. This represents a 26% increase over the previous year.
