### **General Assistance**

A monthly grant for Urbana residents who are disabled or out of work, alongside support to seek/train for work or apply for federal disability payments (SSI)

- 72 current participants
- 8 are homeless
- 41 males / 31 females

#### **Education and Employment Track**

- 15 total participants to date
- 9 participants are currently pursuing the employment track

#### **Disability and Wellness Track**

- 2 participants were awarded SSI in FY 23. 12 participants have been awarded SSI/SSDI in FY22. 16 participants were awarded in FY21.
- 12 residents have been helped to date with submitted applications and intensive SOAR case management since our program started September 1, 2020. Case management for 1 client is about to begin.
- 1 client was represented at their disability hearing last month by our SOAR case manager.
- 4 SSI/SSDI reconsiderations have been submitted.
- Participants are being continuously screened for eligibility for Pinewood Place and placement on the waitlist.

#### **Transportation Assistance**

- MTD began charging bus fares again in July 2021.
- To date: 63 annual passes at \$60 = \$3,780, and
- 57 DASH passes, which are free for those who qualify, saving Township \$3,420.

#### **Rental Assistance**

Rental assistance up to 2 months rent for Urbana households behind on rent or homeless moving into housing.

• 12 households were supported with CTSO Rental Assistance last month.

## **Housing Advocacy**

Housing advocacy for participants who are homeless or at risk of homelessness to access all available subsidized housing opportunities and move in.

#### **Subsidized Housing Advocacy**

 399 participants representing 241 households received help applying to subsidized housing since our advocacy program began July 1, 2020.

108 households have successfully moved in!

#### **Housing First**

- CTSO launched a Housing First program to pay the housing costs for former GA
  participants, who make no income, live in Urbana in subsidized housing, and are at
  risk of homelessness because they are behind in paying their portion of rent. With
  their consent and Supervisor approval, CTSO pays their portion of the rent monthly.
  This is a "low barrier" program the participant agrees to respond to requests from
  our office, and can choose to access deeper case management support when needed.
- 13 former GA participants received the Housing First benefit last month.

#### **COVID Housing Vouchers**

- The Housing Authority has received 163 vouchers for homeless and high risk residents. 50 of these were distributed in the first round. September 6, CTSO started making referrals for the second round of 113 "EHV vouchers."
- CTSO made 76 referrals for EHV and 59 households, or 77%, have been awarded vouchers.

#### **Housewarming Gifts**

- Housewarming gifts are entirely funded by private donations which are used to
  provide vouchers to formerly homeless households to buy furniture and housewares
  at Salt and Light and Habitat for Humanity Restore.
- 41 homeless households have been assisted with the Township Housewarming, since the program began in February, 2021.
- 4 households received housewarming support through Angel Donor Funds last month.

### **Bridge to Home - Countywide Homeless Services**

A continuum of services for the homeless provided by CTSO.

#### **Street Outreach**

Services include food, transportation to services, weather appropriate clothing and engagement events.

- Members of the public are encouraged to call CTSO for wellness checks on residents who may be homeless.
- CTSO is currently supporting 17 households with Street Outreach.
- CTSO is currently analyzing street outreach data to determine unmet needs for those who will not or can not stay in shelter and will be reporting to the CSPH Executive September 21, 2022.

#### **Emergency Housing - Hotel**

If no other shelter option exists, short term emergency housing will be considered as long as the resident is meeting with a case manager, pursuing goals, and seeking permanent housing.

• Last month 6 households were sheltered in a hotel. One household exited into subsidized housing. One household exited to CU@Home.

#### **Rapid Rehousing**

CTSO provides housing stabilization and up to 12 months of rent for literally homeless individuals and families in Champaign County, referred by Centralized Intake for the Homeless.

- 1 active household a married couple with a young child; they are actively looking for employment and ramping up their contribution to household expenses. .
- 2 households exited the program last month both at the end of their 12 month term.
- We will have 4 openings in the program in the coming weeks, with future ESG funding, and will receive referrals from CIH.

#### **Good Morning! Hot Breakfasts for Homeless Residents**

CTSO provides hot breakfast delivery for residents at CU at Home. The service is provided by Red Herring Restaurant and Bridgewater Life Sullivan Center

- In July, 1,170 breakfasts were served.
- From Program Start Feb. 22, 2022 to July 31, 2022, we have served 8965 breakfasts.
- This program is ending in August. CTSO is working with CU at Home to allow residents to access and warm breakfasts on site.

### **Low Barrier Winter Emergency Shelter**

- The Low Barrier Winter Emergency Shelter served homeless residents dealing with mental health or substance abuse issues. It closed April 16, 2022.
- City of Champaign Township reported to the Continuum of Service Providers to the Homeless the following updates:
  - CoCT will operate a low barrier shelter, entitled STRIDES, with a start date in November, 2022. They are resourced to operate the shelter for two years, through October 2024. They will seek funds to remain open after that.
  - Gen Ops funds from the City of Champaign. The Community Foundation will act as their fiscal agent to receive private donations.
  - Capacity is expected to be 50 men and 10 women working on provisions for Trans residents
  - The shelter will operate 27/4 and not require residents to leave, but there will be quiet times.

- There will be no sobriety requirements, but drugs may not be used on the premises. They are taking a harm reduction approach.
- Staffing Program Director and Community Relations Coordinator (who does street outreach) will be hired. CoCT is hiring security in house.
- The location will be leased, and is not yet disclosed.
- Consenting residents will be entered into the Homeless Management Information System (HMIS) and connect to Centralized Intake for the Homeless.
- CTSO is meeting with CoCT to discuss partnership.
- One area of research is how to meet the needs of survivors of sexual violence. We have met with UP Center and RACES and plan to meet with Courage Connection.

### **Emergency Housing for Urbana families**

Emergency Housing for families with children in Urbana schools of Crisis Nursery or residents with disabilities who are referred from CU at Home.

- Total served: 53 households including 59 adults and 94 children (since July 2020)
- Last month: 7 households served. All of these households are still in search of secure housing.
- Currently 20 Urbana children are being served.

### **Housing Case Management in Urbana Schools**

CTSO has an agreement with Urbana School District to locate a full time Housing Case Manager in Urbana Schools.

- Total Referrals: 20, 0 active
- Currently there are no activities in USD buildings, so our Housing Case Manager is supporting the processing of the large volume of rental assistance cases for families, as that is the greatest need.

### **Utility Support**

Privately funded utility bill support for residents who face shut offs.

- 0 Households helped in July, Down from 3 in June.
- Due to the combination of a record number of requests causing a shrinking number of Angel Donor funds, CTSO will only provide utility assistance to residents with an Urbana, Illinois address and a confirmed denial from LIHEAP or LIWHAP starting June 1, 2022. RPC continues to have funds for countywide residents.
- Dozens were referred to RPC's LIHEAP & the new COVID relief Water Assistance.

- 173 households served since program start Nov. 2020
- 145 households served in fiscal year 2022.

### **Digital Inclusion Campaign**

A campaign to supply low income Urbana residents with smartphones, computers, tablets, and internet access.

• Distributed to date:

#Total of benefits: 279

o # Smart Phones and Lifeline service: 229

# Internet benefits: 18# Laptops/tablets: 32

 We have partnered with Cricket Wireless who attend our events and provide tech support and activations. In addition they screen and provide e free phones and service through the ACP benefit to qualifying residents at their Urbana location.

#### **Food Assistance**

CTSO funds Channing Murray Foundation to provide the Bucket Brigade weekly food pantry delivery service to residents who are in need.

- Bucket Brigade—which was established at the start of Covid quarantine—is shifting focus. A hiatus will be taken, with no deliveries the weeks of August 17th and 24th. When deliveries begin again on August 31st:
  - They will be limited to 20 per week, except emergency shelter recipients who receive modified "hotel packs."
  - Priority will be given to those with mobility issues and/or medical issues, or residents with temporary issues with LINK/food stamps. In some cases, the deliveries will be recurring for a set amount of time.
  - Deliveries will be to residents with an Urbana address.

#### **Vaccination Assistance**

- CTSO had been offering \$50 to any current CTSO participant who presents a complete vaccination card at CTSO and \$25 for each child.
- 63 participants have received this incentive.
- We are working to have on site vaccinations once per month.

## AN ORDINANCE APPROVING THE CUNNINGHAM TOWNSHIP ANNUAL BUDGET - REVISED FISCAL YEAR 2021-2022

That the fiscal year of this Town is hereby fixed and declared to be from July 1, 2021 - June 30, 2022; That the following budget, incorporated herein, containing an estimate of receipt of the Town and General Assistance funds, is hereby adopted as the budget of this Town and General Assistance funds, and shall be in full force and effect from and after this date;

That there is an estimate of the beginning balance of July 1, 2021 in the amount of

Town Fund \$544,148
General Assistance Fund \$650,758
Total All Funds \$1,194,906

That the estimate of cash to be received during the Fiscal year, from all sources is

Town Fund \$1,386,677
General Assistance Fund \$1,608,336
Total All Funds \$2,995,013

That the estimate of expenses for each of the aforementioned funds is

Town Fund \$881,515
General Assistance Fund \$1,394,100
Total All Funds \$2,275,615

That the ending balance at the end of the Fiscal Year, June 30, 2022 is estimated to be

Town Fund \$1,049,310 General Assistance Fund \$864,994 Total All Funds \$1,914,304

That the following budget is the Annual Appropriation Ordinance of this Town, passed by the Township Board of the Town of Cunningham as required by law, and shall be in full force and effect from and after this date. Adopted on September 12, 2022 by the Township Board of the Town of Cunningham in the County of Champaign, State of Illinois, in meeting assembled.
