Town Bills Report

- Town fund = \$51,527.58
- General Assistance Fund = \$72,002.11
- TOTAL in expenditures = \$123,529.69

INCOME SUPPORT

General Assistance

A monthly grant for Urbana residents who are disabled or out of work, alongside support to seek/train for work or apply for federal disability payments (SSI)

- 53 current participants (down from 58 last month)
- 6 are homeless (up from 5 last month)
- 32 identify as male, 20 as females, and 1 non-binary
- 36 applications for General Assistance were submitted during the month of December (up from 29 last month)

Education and Employment Track

- 12 current participants
 - 6 participants are currently pursuing the employment track
 - 2 currently pursuing education
 - 4 medically exempt due to illness/injury



Disability and Wellness Track

- 39 participants
- Social Security Help
 - 5 participants were awarded SSI in FY 23 so far. (12 participants were awarded SSI/SSDI in FY22.)
 - o 15 residents have been helped to date with submitted applications and

intensive SOAR case management since our program started September 1, 2020.

- o 1 resident is about to begin SOAR case management.
- 6 SSI/SSDI reconsiderations have been submitted.
- 1 participant assisted with locating lawyers for SSI appeal assistance.

Health Care Navigation

- o 2 participants given medical advocacy for issues with medication
- o 2 participants and 2 GA applicants referred to Rosecrance's The Living Room.
- 3 participants, who require deeper case management than Township provides, referred to Rosecrance for case management.
- 1 participant, who needed to obtain prescriptions for needed medical supplies, referred to Carle Social Worker.

Other referrals

- 2 participants referred to Department of Rehabilitation Services (DRS). The organization assists those with disabilities find jobs that can accommodate their physical and/or mental health needs.
- 1 participant referred to LifeLinks for employment search assistance.
- 12 participants received benefit confirmation letters to recertify for food stamps, medical care, or housing assistance.

Transportation Assistance

- 91 annual passes at \$60 (\$5,560)
- 61 DASH passes, which are free for those with disabilities who qualify (saving Township \$3,660) since MTD began to charge bus fare again July 2021.
- After a hiatus in our being able to get DASH passes for our participants approved, we
 have partnerships with two organizations to assist us with this: PACE and DRS.
- DASH passes take time to process. In two cases we purchased a monthly pass to ensure someone had transportation while waiting on their DASH pass.

HOUSING SUPPORT

Rental Assistance

Rental assistance for Urbana households behind on rent or homeless moving into housing.

- 8 households were supported with CTSO Rental Assistance for the month of December.
- We continue to receive a record number of rental assistance cases about 80 applications per month, about double the typical submission.

- We budgeted \$125,000 in rental assistance this year and have spent \$104,666 or 83.7% as of January 1, 2023.
- Cunningham Township is submitting a proposal for Urbana ARPA funds for Rental Assistance in light of the increase in demand due to pandemic recovery and the need to expand Rental Assistance to help Homelessness Families.



Housing Advocacy

Housing advocacy for participants who are homeless or at risk of homelessness to access all available subsidized housing opportunities and move in.

Subsidized Housing Advocacy

 448 participants representing 269 households received help applying to subsidized housing since our advocacy program began July 1, 2020.

124 households have moved in!

Congratulations on your NEW HOME

Housing First Program

- These are direct payments to subsidized housing providers to keep CTSO participants in their homes. Participants are offered this service who have trouble paying rent regularly and must agree to direct payments and case management.
- 15 participants received the Housing First benefit last month 2 are former GA participants and 13 are current participants.

Housewarming Gifts

- Housewarming gifts are entirely funded by private donations which are used to
 provide vouchers to formerly homeless households to buy furniture and housewares
 at Salt and Light and Habitat for Humanity Restore.
- 60 homeless households have been assisted with the Township Housewarming, since the program began in February, 2021.
- 2 households received housewarming support through Angel Donor Funds last month.

Bridge to Home

A continuum of services for homeless residents in Champaign County.

Street Outreach

Services include food, transportation to services, weather appropriate clothing and engagement events.

- Members of the public are encouraged to call CTSO for wellness checks on residents who may be homeless.
- CTSO served 35 households with street outreach in the month of December. This is down from 40 served in November of 2022.

Christmas Storm

In preparation for the storm that plunged CU into sub zero temperatures, CTSO:

- Conducted multiple outreach attempts to all 35 street outreach participants and everyone on STRIDES waitlist offering support to move into CTSO's or other emergency shelters.
- Coordinated with area shelters to ensure all available beds were used. Thank you to STRIDES and MTD for expanding capacity
- Lined up 12 CTSO volunteers and staff for an overflow shelter run by Canteen Run at Salvation Army huge thanks to our volunteers.
- Continued outreach over the holiday weekend December 24, 25, 26, 27 thank you Martel Miller!
- Monitored a temporary loss of heat at Steer Place, conducting wellness checks with participants living at Steer.
- Supervisor took numerous calls for help over the weekend to help direct homeless residents.
- As a result, no residents were turned away from shelter during the storm.

Emergency Housing - Hotel

If no other shelter option exists, short term emergency housing will be considered as long as the resident is meeting with a case manager, pursuing goals, and seeking permanent housing.

- Last month 8 households were sheltered in a hotel.
- All community shelters remain full or close to full.

Rapid Rehousing

CTSO provides housing stabilization and up to 12 months of rent for literally homeless individuals and families in Champaign County, referred by Centralized Intake for the

Homeless.

- 1 household a married couple with a young child; they are ramping up their contribution to household expenses and are slated to successfully exit the program early Spring 2023.
- 1 household a mother with two young children was able to move into housing right before the holidays.
- 1 household a mother with two young children working on income stability and looking for housing.
- 2 additional openings in the program awaiting a referral from CIH.

Emergency Housing for Urbana families

Emergency Housing for families with children in Urbana schools of Crisis Nursery or residents with disabilities who are referred from CU at Home.

- Total served: 60 households including 68 adults and 106 children (since July 2020)
- Last month: 8 households served. 1 new family entered the property to start case management. We had 1 family find stable housing with a Permanent Supportive Housing voucher.
- Currently 9 Urbana children are being served, 7 of those are school aged.
- We currently have no actively unsheltered families on our waitlist.

Housing Case Management in Urbana Schools

USD 116 funds a CTSO Housing Case Manager who works in all schools to identify families that are homeless, housing insecure, or facing issues with rent and provide services.

- Total Referrals: 55 families (since program start 4/21/22)
- USD Referrals actively in CTSO shelter: 6 families

UTILITY SUPPORT

Utility Support

Privately funded utility bill support for Urbana residents who face shut offs.

- Dozens were referred to RPC's LIHEAP & the COVID relief Water Assistance.
- 1 household received water assistance in the month of December power shut off are discontinued due to weather.
- 187 households (\$72,814) served since program start Nov. 2020

Digital Inclusion Campaign

A campaign to supply low income Urbana residents with smartphones, computers, tablets, and internet access.

Distributed to date:

o #Total of benefits: 456

o # Smart Phones and Lifeline service: 400

Internet benefits: 18# Laptops/tablets: 38

• We have partnered with Cricket Wireless who attend our events and provide tech support and activations. In addition they screen and provide e free phones and service through the ACP benefit to qualifying residents at their Urbana location.

FOOD SUPPORT

Bucket Brigade Food Delivery Service

A collaboration with the Channing Murray Foundation to provide a free weekly food pantry delivery service to low-income residents in Urbana who are unable to access walk-in food pantries. It is meant to be a temporary service to residents while CTSO works with residents to address underlying causes of food insecurity.

- In the month of December, we served:
 - 48 households with Bucket Brigade Deliveries
 - 37 adults serviced
 - 16 children
 - Plus 22 "hotel pack" recipients
- The United Way has also started a similar program through RIDE United. This program allows for deliveries from food pantries within 10 miles of the pantry, with no limit on the amount of deliveries are possible, or how often someone can use this program.
 - Over the last month, we have been able to sign up 8 households for the RIDE United Program.

Solidarity Gardens

A collaboration with the Urbana Park District, Urbana Free Library, Sola Gratia, the Channing Murray Foundation, and area community gardens to reduce local food insecurity by supporting existing and new gardens to produce and distribute produce to those in need.

• Solidarity Gardens will be holding a planning retreat with all SG members in late January to plan our next season.

SUBJECT: Process for Filling Township Assessor Vacancy

Introduction

Cunningham Township Assessor Wayne Williams has submitted his resignation effective February 13, 2023.

Proposed Process

The Cunningham Township Board seeks to fill a vacancy in the office of Township Assessor effective February 13, 2023. Per the Township Code/Property Tax Code, qualifications to hold this office include:

- 1. Applicant must be a legally registered voter.
- 2. Applicant must have been a resident of Cunningham Township (co-terminus with the City of Urbana) for one year prior to February 13, 2022.
- 3. Applicant must have successfully completed a course of study or designation by an approved professional assessing or appraisal association. The applicant must possess at least <u>one</u> of the following qualifications:
 - a. A currently active Certified Illinois Assessing Officer designation from the Illinois Property Assessment Institute;
 - b. A currently active AAS, CAE, or MAS designation from the International Association of Assessing Officers;
 - c. A currently active MAI, SREA, SRPA, SRA, or RM designation from the Appraisal Institute; or
 - d. A currently active professional designation by any other appraisal or assessing association approved by the Department.
- 4. Applicant must be affiliated with the same political party (Democratic) as the person vacating the office. Party affiliation may be established by their record of voting in party primary elections or by holding/having held an office in the party organization before the appointment. If the applicant has done neither of the above, affiliation is established based on their record of participating in a political party's nomination or election caucus.
- 5. Applicant is NOT eligible to hold a township office if that person at the time of taking the oath of office has been convicted in any court in the United States of any infamous crime, bribery, perjury, or other felony. (60 ILCS1/55-6.)

Individuals who wish to apply for this position should submit a cover letter, proof of at least one of the above-referenced certifications, proof of party affiliation, and resume by 5 pm on January 31,

Copies of application documents from all applicants will be provided to Cunningham Town Board members, Cunningham Township Supervisor, Cunningham Township Assessor, and Cunningham Township Attorney in advance of the February 13 Town Board Meeting.

The Cunningham Town Board will nominate and vote on the appointment of a qualified individual to fill the vacancy in the office of Township Assessor at the February 13, 2023 Town Board Meeting.
